

16. DIGITAL NOMAD VISA APPLICATION PROCESS

A citizen of a foreign country, who wishes to work in Türkiye as a digital nomad, must enter Türkiye on a Digital Nomad visa.

Only the nationals of the countries listed below can apply for the said visa:

Australia, Denmark, Hungary, Luxembourg, Russia, Ukraine, Belarus, Estonia, Iceland, Malta Slovakia USA, Belgium Finland Ireland The Netherlands Slovenia, Bulgaria France, Italy Norway Spain, Canada Estonia Latvia Poland Sweden, Croatia Germany Lichtenstein Portugal Switzerland, Czechia Greece Lithuania Romania UK

Application Procedure:

1. Make your pre-application on <https://digitalnomads.goturkiye.com/>
2. Get your pre-application form with a QR code and print it.
3. Assemble the required documents listed below.
4. Start an online application on www.visa.gov.tr and upload the documents when prompted.
5. Print out the application form.
6. After submitting the application successfully, schedule an appointment for the interview which will take place at the Consulate.
7. Be present at the Consulate on the day of the interview with the hard copies of all required documents listed below.

Required Documents:

1. Pre-application form with a QR code (obtained from <https://digitalnomads.goturkiye.com/>)
2. If the digital nomad works for a company, the contract signed by both parties.
3. If the digital nomad is a freelancer, official letter from the company stating details of the project s/he works on.
4. Certificate of good conduct that can be obtained from your local police department.
5. Proof of lodging.
 - If you are going to be hosted, a notarized invitation letter must be submitted.
6. Flight reservation indicating your intended travel dates. (These reservations do not need to be purchased yet)
7. Bank statements of last 3 months.
 - If you are going to be sponsored for your education, a letter and a bank statement of your sponsor must be submitted.
8. Proof of travel health/accident insurance, valid through duration of stay, including:
 - a) minimum coverage of 30,000 Euros or equivalent USD

b) transfer of the patient to nearest healthcare facility or residency address after discharge and transfer of body in case of death,

9. Non-refundable visa fee

- Single Entry: \$60.00(\$185.00 USA citizens).
- Multiple Entry: \$180.00 (\$265.00 USA citizens).

Optional:

10. A pre-paid envelope (USPS mail carrier)

(Turkish Consulate General in Houston is not responsible for any delivery issues)

Important Notes:

- Visa applicants should be resident in our jurisdiction area (Arkansas, Alabama, Louisiana, Mississippi, New Meksiko, Oklahoma, Tennessee ve Teksas)
- After making your pre-application, you must get your appointment at the Consulate General in 30 days.
- Applicants are required to bring hard copies of the documents on the day of the interview.
- In the event that neither Turkish nor English is spoken, every applicant is required to arrange for a translator to accompany them to their interview. Failure to do so will result in rescheduling the appointment with the stipulation that a translator must be present.
- Screenshots will not be accepted. Documents are requested in their original size.
- The documents such as travel insurance, flight and hotel reservations must contain the name and surname of the applicant/s.
- It is strongly advised for applicants to apply **at least one month(during summer season at least 3 month)** prior to their intended trip.
- In individual cases, the applicant may be required to provide additional documents which may delay the visa issuance.
- Turkish Consulate General in Houston **cannot expedite a visa application.**
- Please do not finalize your travel arrangements until you are notified about the outcome of your visa application.
